Irene LeVangie made a motion to submit draft Rules and Regulations updates to the Association's attorney at HindmanSanchez for review. Ray Garcia seconded the motion. The motion carried unanimously.

Irene LeVangie made a motion to have Chieftain Construction remove siding and exterior drywall at 5756 and 5758 W. Atlantic Place due to signs of squirrels nesting in the fresh air vent for the fireplace. Cost not to exceed \$1,000. Ray Garcia seconded the motion. The motion carried unanimously.

The Board is requesting permission from SunPointe Common Maintenance Association to run downspouts from building 6 in to the existing storm sewer, which SunPointe Common Maintenance maintains. If allowed this should move water from the roof of building 6 away from the building and not allow downspout to drain over the common sidewalk.

Ron Fischer made a motion to approve DRS Engineering Contractors proposal to repair the Jewell Street fence damage by a vehicle for \$4,604, work on fence will coincide with building 6 patio replacement project. Ray Garcia seconded the motion. The motion carried unanimously.

Building 19 landscape proposal was tabled for more information and meeting with designer. The Board asked management to talk to the Association's attorney about options on how to get the owner of 5734 W. Atlantic Place who has rented his unit with out requesting a leasing permit from the Board of Directors.

The Board approved the following design review requests from Mr. Gardner of 5830 W. Atlantic Place Installation of a ceiling fan in the two second floor bedrooms.

Installation of replacement windows.

Remodel of the second floor bathroom was approved pending final design submitted to the Board for review.
